The Finance Officer submitted his confidential report (circulated with Agenda) which referred to the recent tendering exercise undertaken in relation to the Council's insurance contract for 2010-2013.

19. 'RHYL IN BLOOM' - REQUEST TO USE THE TOWN CREST

The Town Clerk's confidential report (circulated with Agenda) was presented explaining the difference between allowing the use of the Town Crest and its "supported by" logo featuring the Town Crest, and that the latter should be considered in this particular case and all future requests.

RESOLVED that:

- b) previous permissions granted by the Town Council be referred to its Risk Assessment Sub-Committee for consideration of appropriate action.

20. RHYL LITTLE THEATRE LIMITED

The report included a range of information and correspondence relating to the Theatre's most recent application to the Town Council for funding. Whilst the County Council had been asked to provide a position statement in relation to the status of the Rhyl Little Theatre Ltd and to the lease of the building, this had not yet been received and the Town Clerk's advice was to defer consideration accordingly.

During debate some Members felt that the Town Council should be more proactive in forcing a response from Denbighshire County Council, enabling the Council to respond to the Theatre. The Finance Officer informed Members that the Theatre's request had been acknowledged by letter and the Town Council's request for further information from the County Council made known.

21. REQUEST FOR FINANCIAL ASSISTANCE - 'RHYL IN BLOOM'

The Finance Officer submitted his confidential report (circulated with Agenda) which referred to a recent request for funding of £100 from the 'Rhyl in Bloom' Committee towards a planned flower show.

The report advised that the relevant budget had been entirely exhausted due to earlier decisions in the year. The Finance Officer explained that although the sum requested was relatively small the principal was important and indeed this situation had been forecast at the time of earlier decisions. If the general consensus was to approve the request then the funds would have to come from balances.

After further debate, Councillor G. J. Pickering proposed that the request be regretfully declined due to the Town Council's financial position, and the proposal was seconded by Councillor M. C. Espley but on being put to the vote the proposal was lost.
