Also that the Risk Assessment Sub-Committee be advised that it should conclude the work within the report of the Internal Auditor in relation to Contract Standing Orders as soon as possible.

23. CONSULTATION: FIELDS IN TRUST - PROPOSED OUTDOOR GYM, EAST PARADE, RHYL.

The Chair reported receipt of the above proposal from Denbighshire County Council (circulated with Agenda).

RESOLVED that the proposal be approved.

FURTHER RESOLVED that Standing Orders be suspended to enable the Town Clerk to act as a matter of urgency.

24. PROVISION OF COMMUNAL BINS - BRUTON PARK, RHYL.

Further to Minute No.200 of the meeting held on 2nd March 2011, the Chair reported receipt of correspondence from Denbighshire County Council in response to representations made by the Town Council (circulated with Agenda).

RESOLVED that the correspondence be received.

25. NOTIFICATION OF ROAD CLOSURE - B5119, WEST PARADE, RHYL.

The Chair reported receipt of the above Notice from Denbighshire County Council (circulated with Agenda).

Members spoke of receiving numerous complaints from residents about the delays being caused by the road closures whilst the major coastal defence construction works are underway, and particularly by the temporary traffic lights in operation on the Foryd Bridge, introduced just this week, which were adding to the problem.

RESOLVED that the Notice be received.

26. <u>APPOINTMENT OF REPRESENTATIVES ON OUTSIDE ORGANISATIONS –</u> CONNECT 2 STEERING GROUP

The Chair reported the resignation of Councillor Mrs J. Chamberlain-Jones as the Town Council's appointed representative on the above group, and requested that Members consider appointing an alternative representative.

The Town Clerk advised that the Steering Group acted as liaison between the community and Denbighshire County Council on the proposed new footbridge in the vicinity of the Foryd Harbour.

RESOLVED that the current substitute, Councillor M. C. Espley, becomes the representative and Councillor Ms G. A. Jones be appointed as the new substitute.

27. MEMBERS ITEM: BUS SHELTER, KINGSLEY AVENUE, RHYL.

Councillor D. A. J. Thomas sought Members' 'in principle' financial and other support in providing a bus shelter on Kingsley Avenue, subject to consultation with Denbighshire County Council and local residents and the envisaged cost implications.

RESOLVED that the Town Clerk consults with Denbighshire County Council and residents on Kingsley Avenue on the possible introduction of a bus shelter and the costs this would incur.

28. MEMBERS ITEM: RHYL SKYTOWER

The Mayor, Councillor Mrs W. M. Mullen-James, sought Members' support for a letter to be sent to Denbighshire County Council to ask what was to become of Rhyl's landmark Skytower, now it was in their ownership.

RESOLVED that the Town Clerk to write to the County Council to make the request and to also ask that the matter is brought to the Rhyl Members Group meeting for further consideration.

29. ADDITIONAL ITEM: STRATEGIC REGENERATION FRAMEWORK

The Town Clerk informed the meeting that Mr Tom Booty had requested permission to return to the Town Council following his meeting with a delegation from the Town Council in June to provide an update on the document.

RESOLVED that Mr Booty be invited to the meeting of Council to be held on 20th July 2011.

30. EXCLUSION OF PRESS AND PUBLIC

RESOLVED that the Press and Public be excluded from the Meeting for consideration of the following items of business in accordance with Section 1(2) of the Public Bodies (Admission to Meetings) Act, 1960, on the grounds of confidentiality.

31. CODE OF CONDUCT COMPLAINT

The Chair reported receipt of correspondence from the Public Services Ombudsman (circulated with Agenda) advising that he does not intend to investigate a complaint made against a Member of the Council.

RESOLVED that the correspondence be received.

32. CONSULTATION: WEST KINMEL STREET CAR PARK, RHYL.

The Chair reported receipt of the above confidential correspondence (circulated with Agenda) from Denbighshire County Council advising of a proposal they have received that would affect the car park on West Kinmel Street.

The Town Clerk advised that at this stage the County Council would like to know the Town Council's initial thoughts on the proposal, and that the a formal application would follow via the Town Council's Planning Committee, should the plans be progressed.

RESOLVED that:

- a) the correspondence be received.
- b) the Town Clerk conveys to Denbighshire County Council that Members are unhappy with the potential loss of 25 parking spaces in an area where parking is already at a premium, and the possible impact the proposal might have on residents' parking permits.

33. RISK ASSESSMENT SUB-COMMITTEE REPORT

The Chair referred to the confidential report of the Town Council's Risk Assessment Sub-Committee (circulated with Agenda). He advised that the members of the Sub-Committee had met with the Town Council's Internal Auditor, who had stressed the Town Council's responsibility to manage some areas of identified risk more robustly and within a defined time period.

For clarity, the Chair read aloud the Sub-Committee's three specific recommendations.

A Member of the Town Council's former RCA Working Group which had been disbanded by the Council, expressed their frustration that the recommendations before them now were very similar to those determined some time ago by the Working Group.

RESOLVED that the report be received, with all of the Sub-Committee's recommendations approved.

34. RHYL COMMUNITY ASSOCIATION

Further to Minute No.15 of the meeting held on 1st June 2011, the Chair referred to the confidential paper previously circulated to Members at their request, which outlined the issues still outstanding between the Town Council and the Rhyl Community Association.

Members stated that the previous item would now hopefully tackle the outstanding issues to the satisfaction of the Town Council.

RESOLVED that the correspondence be received.
