205. APPLICATIONS FOR GRANT AID

The Finance Officer introduced and presented his confidential report (circulated with Agenda), relating to applications received in response to the Town Council's public invitation to voluntary and charitable organisations to apply for grant aid for the year 2011/2012.

The report:

- (i) identified the Terms of Reference of the Committee and indicated that the Committee's recommendations would be referred to the Council meeting to be held on 20th April 2011.
- (ii) identified the emphasis that had been placed upon the organisation's response to the question of the benefit to Rhyl and that the organisation's own words had been used within the written report.
- (iii) reminded Members that they should consider whether they have a personal or prejudicial interest in any applications and whether the Rhyl Town Council Code of Conduct requires them to disclose that interest.

- (iv) advised that full copies of all applications were available for inspection at the meeting.
- (v) advised of the necessary budget and legal considerations.
- (vi) Appendix A to the report, which listed named organisations within the Council's budget that had submitted a valid application.
- (vii) Appendix B to the report, which identified other organisations, which had submitted valid applications and advised that there was a significant shortfall due to the applicant organisations having requested sums in total greater than in the Budget.
- (viii) Appendix C to the report, identifying organisations which had been sent application forms on request, but which had subsequently failed to make an application. In addition the Appendix identified one withdrawn application and two rejected applications due to the provision of inadequate documentation.
- (ix) Appendix D to the report, identifying the relevant budgets available.
- (x) Appendix E to the report, a copy of the Grant Application Form and accompanying Advice to Applicants.
- (xi) identified a suggested procedure to be followed by the Committee in determining the applications.

The Committee considered each application individually in turn and when completed was advised by the Finance Officer that the recommended awards had come in under budget by £4,650. The Finance Officer invited the Committee to determine whether to hold the amount in Reserves to meet any potential applications for grant within the year or alternatively to reconsider some or all applications again with a view to awarding revised grants.
