# 181. EXCLUSION OF PRESS AND PUBLIC

### 182. APPLICATIONS FOR GRANT AID

The Finance Officer introduced and presented his confidential report (circulated with Agenda), relating to applications received in response to the Town Council's public invitation to voluntary and charitable organisations to apply for grant aid for the year 2012/2013.

The report:

- (i) identified the Terms of Reference of the Committee and indicated that the Committee's recommendations would be referred to the Council meeting to be held on 18<sup>th</sup> April 2012.
- (ii) identified the emphasis that had been placed upon the organisation's response to the question of the benefit to Rhyl and that the organisation's own words had been used within the written report.
- (iii) reminded Members that they should consider whether they have a personal or prejudicial interest in any applications and whether the Rhyl Town Council Code of Conduct required them to disclose that interest.

- (iv) advised that full copies of all applications were available for inspection at the meeting.
- (v) advised of the necessary budget and legal considerations.
- (vi) Appendix A to the report, which listed named organisations within the Council's budget that had submitted a valid application and advised that there was a shortfall due to the applicants having requested sums in total greater than in the Budget.
- (vii) Appendix B to the report, which identified other organisations, which had submitted valid applications and advised that there was a significant shortfall due to the applicant organisations having requested sums in total greater than in the Budget.
- (viii) Appendix C to the report, identifying organisations which had been sent application forms on request, but which had subsequently failed to make an application. In addition the Appendix identified one rejected application due its submission 10 days after the closing date.
- (ix) Appendix D to the report, identifying the relevant budgets available.
- (x) Appendix E to the report, a copy of the Grant Application Form and accompanying Advice to Applicants.
- (xi) identified a suggested procedure to be followed by the Committee in determining the applications.

With regard to the procedure the Committee decided to consider Appendix A applications followed by Appendix B applications for under £1,000 and finally all other applications. Having considered all applications individually by this method the committee was advised by the Finance Officer that the provisional recommended awards were marginally over budget by £1,100. The Committee decided that it would reconsider just the provisional awards made to the value of £1,000 or above to determine reductions that would match the required sum and this achieved the desired outcome so all other predetermined awards were confirmed as final.
