44. <u>ADDITIONAL ITEM: TOWN CENTRE MANAGEMENT GROUP - REPORT OF REPRESENTATIVES</u>

Further to Minute. No.44 of the Finance and General Purposes Committee held on 5th September 2013, the Mayor invited his fellow representative, Councillor A. R. James, on the above Group to update Members on the outcome of the meeting of the Group on Friday 6th September.

Councillor James confirmed that both he and Councillor Rutherford had attended the meeting on 6th September, which had largely centred around the merits of filling the position for the remaining 18 months of the contract, how the future post would link in with Denbighshire County Councils Events Manager, Sian Davies and who would help to fund the post beyond March 2014, when the Welsh Governments contribution would come to an end.

Councillors James and Rutherford supported the suggestion to meet with neighbouring Councils who have a TCM to explore the nature of their roles, how they are managed and funded, etc, and it was agreed that Denbighshire County Councils Mark Dixon would arrange a visit to Mold.

The next meeting of the TCM Group would be on 14th October and until then no decisions would be taken.

45. REPORT FROM COUNCILLOR D. SIMMONS

Councillor Simmons advised that of the £1.4b of European Objective One funding available for Wales, the North East area was set to receive £345m and sought Members' support to develop a Town Council policy to ensure that Rhyl secured a good share of it.

Councillor Simmons stated that the main criteria for the funding would focus on employment, regeneration and community and as such the Members should keep these in mind when identifying project in their Wards.

Councillor Simmons added that he had spoken to the Leader of Denbighshire County Council about the potential windfall for the North East of Wales and that the Leader had advised him to take this information to the Town Council and for it to decide on major projects it would like to see in Rhyl.
