70. CHANGING PERCEPTIONS - YEAR 3

Further to minute no.116 of 17th February 2016 the Town Clerk submitted progress report for the Changing Perceptions initiative and sought confirmation that the Council would wish to contribute to year 3 of the programme.

The Town Council's appointed representative, Councillor A.J. Rutherford advised that he felt that it would be beneficial to continue with the initiative for the final year.

RESOLVED that the Town Council continue to participate in the initiative for the third and final year.

71. BRITISH DESTINATIONS

The Town Clerk advised that the renewal of the annual subscription to the above organisation was now due and sought Members instructions as to whether it was of advantage to renew.

RESOLVED that membership be discontinued.

72. <u>APPOINTMENT OF REPRESENTATIVES ON OUTSIDE BODIES - RHYL BUSINESS GROUP</u>

Further to minute no.101 of the meeting held on 6th April 2016 the Chairman advised of difficulties he was experiencing in attending meetings of the Rhyl Business Group and requested the Committee to appoint a replacement representative.

The Chair advised on his reasons for being unable to commit to attending meetings of the Business Group

<u>**RESOLVED**</u> that Councillor Tony Thomas be appointed as the Town Council representative.

73. CONSULTATION: DENBIGHSHIRE COUNTY COUNCIL - (TRELLEWELYN ROAD, RHYL) (20 mph SPEED RESTRICTION) ORDER 201

The Chairman submitted details of proposals (copy circulated with Agenda) for the introduction of a 20 mph speed restriction in Trellewelyn Road and sought Members views.

Members expressed concerns that experience in other areas of the Town where the 20 mph restriction had been introduced had caused confusion for drivers (especially where the speed varied at different times of day such as at Rhyl High School), was not adhered to by a number of drivers who either did not appreciate the limit or chose to ignore it, and that associated traffic calming such as speed humps appeared to have been poorly installed.

Members also commented on recent news stories where it was suggested that other areas were now ceasing to introduce such measures due to environmental concerns.

RESOLVED that the proposal be supported subject to it being enforced.

74. CONSULTATION: DENBIGHSHIRE COUNTY COUNCIL - COUNCIL TAX PREMIUM ON SECOND HOMES AND LONG TERM EMPTY HOMES

The Chairman submitted details (copy circulated with Agenda) of the proposed introduction of additional Council Tax on long term empty properties and second homes in the County and sought the Town Council's views

The Town Clerk advised that the proposal would not impact on the level of funding charged/received by Community Councils and that funds raised would be used to support local initiatives.

<u>RESOLVED</u> that the proposal be supported subject to any funding raised be utilised by the County within the Community area from which it was raised for returning empty properties to occupation.

75. <u>INFORMATION: BETSI CADWALDR UNIVERSITY HEALTH BOARD –</u> PROPOSED NEW HOSPITAL IN RHYL FOR NORTH DENBIGHSHIRE

RESOLVED that the information be received and the Town Clerk write to the Health Board stressing the importance of the inclusion of a minor injury facility at the hospital.

Members in welcoming the document for the Rhyl East area expressed their disappointment with NRW in not liaising properly with the other volunteer flood wardens throughout Rhyl including the Town's senior warden, who despite having undertaken training were not receiving communications from NRW.

<u>RESOLVED</u> that the Town Clerk write to the NRW requesting a full list of flood wardens in Rhyl and expressing disappointment with the level of communications with the Wardens in the area

77. <u>INFORMATION ITEM: GUIDE TO TOWN AND COMMUNITY COUNCIL ELECTIONS</u>

The Chairman submitted the above document (copy circulated with Agenda) for the information of Members.

The Town Clerk advised that he would request 22 nomination packs for existing Members.

RESOLVED that the report be received.

78. MEMBERS ITEM - COUNCILLOR P. PRENDERGAST

Councillor P. Prendergast advised Members of concerns he had received from Members of the public in relation to the Bonfire specifically in relation to the collection of entrance monies.

Other Members advised on concerns that had been expressed to them specifically in respect of litter at the field.

The Town Clerk advised of the response from the Rhyl Fire Station Welfare and Recreation Club and the reasons for the issues identified and how they had been addressed.

The Chair confirmed that the field had been cleared of litter the day following the bonfire.

The Chair reminded Members that Councillor S. Ratcliffe had been appointed by the Council to act as liaison with the Welfare Club to hold post event meeting to discuss such issues.

RESOLVED that Councillor S. Ratcliffe raise the issues when meeting with the Welfare Club and offer the assistance of Town Councillors as additional wardens at future events.

79. MEMBERS ITEM - COUNCILLORS B. MELLOR AND D. SIMMONS

The two Members referred to incidents of anti-social behaviour occurring in the vicinity of Hilton Drive and requested that an item be included on a future agenda for the Council to consider funding an additional street column.
