30. OPENING OF MEETING

The Mayor's Chaplain, Rev. Andy Grimwood, commenced proceedings by leading all present in prayer.

33. MAYOR'S REPORT

The Deputy Mayor referred to the list of engagements he and the Mayor had attended over the last month and in particular to his attendance at St. David's Care Home for a very enjoyable 107th birthday celebration.

34. <u>PRESENTATION: DENBIGHSHIRE COUNTY COUNCIL – ENFORCEMENT OFFICERS</u>

The Chair welcomed to the meeting Mr Tim Wynne-Evans, Senior Public Protection Officer and Mr John Dunn and Mr Warren Hodgkinson, both from Kingdom, to provide Councillors with an update on enforcement activities in Rhyl and to respond to Members' questions.

Mr Wynne-Evans initially apologised for his failure to attend previous meetings and advised:

- on the history of the County Council's enforcement regime from 2012 to address environmental crime which was a national problem.
- that the County Council had initially appointed Kingdom's predecessor to undertake the contract for litter and dog fouling enforcement.
- that the Kingdom team in Denbighshire comprised of six officers (one Team Leader, one Administration and four Operational Officers) and now responded to Littering, Dog Fouling, Graffiti, Fly Posting and smoking in enclosed places.
- on the Enforcement Officers uniform.
- of initiatives and tactics utilised which concentrated on hotspots and intelligence led patrols but also included distribution of dog waste bags, "stubby" pouches, education, 'Bin it to win it' competitions, personal cameras on operatives, and more recently the deployment of mobile CCTV cameras with appropriate signage.
- on the outcome being a cleaner county with national acknowledgement and a fall in the number of tickets having to be issued over the four year period.
- that complaints about the issue of tickets represented 1.036% of the
 total issued and the importance of the operatives cameras in resolving
 disputed tickets. That complaints against operational officers were
 falling but where there was clear evidence that a particular officer was
 not acting in accordance with proper procedure, they were either
 subject to training or replaced by Kingdom.

In response to Members' questions the Officers advised that:

- a specific hot spot identified by Councillors had been noted but Members should report such locations to the County Council so as to enable them to be monitored.
- in the event of an enforcement officer's actions resulting in legal action against the authority, depending upon the nature of the actions, it was likely that Kingdom would need to respond.
- the Council could not control social media comments.
- Mr Wynne-Evans would examine CCTV at the Green Gym on the promenade to ensure appropriate signage.

- they welcomed the idea of entering schools to provide environmental crime education for young people, however the priority in schools was highway safety.
- they would investigate further the amount of time spent by officers in cars and while this was not classed as covert surveillance it was important to achieve a balance between foot patrols and time spent in vehicles.
- they would seek to provide statistics as to where tickets had actually been issued.
- they would ensure that appropriate and clear contact details were included on the tickets issued.

At the conclusion of the presentation the Deputy Mayor thanked the officers for their attendance and presentation.

35. <u>REPRESENTATIVES ON OUTSIDE ORGANISATIONS – RHYL WEST NEIGHBOURHOOD POLICE GROUP</u>

Further to minute no.26 of the Finance and General Purposes Committee held on 6th July 2016, the appointed representative advised upon her attendance at the above Group and indicated:

- that housing association letting policies for tenancies were weak on addressing issues of tenants using drugs.
- there had been 16 arrests for drugs over the past month within Rhyl.
- an issue of modern day slavery having been identified within Denbighshire.
- significant child deprivation in the town.
- the evolving role of Communities first in Rhyl.

RESOLVED that the information be received and the Member thanked for her report.

36. COASTAL COMMUNITIES FUND

Councillor Mrs J. Butterfield JP MBE advised upon the availability of the above fund (copy of press release enclosed).

The Town Clerk advised that Council policy was not to provide grant funding to external organisations. The Town Clerk further advised that should members wish to review the policy it should be referred to SOP Committee for consideration.

RESOLVED that the application be declined and a letter be sent to the group explaining the Town Council policy and the availability of alternative funding within Rhyl.

42. EVENTS ARENA – FAN ZONE

The Town Clerk sought Members' confirmation of the Council, in partnership with Denbighshire County Council, providing a Fan Zone at the Events Arena and the final costs thereof.

The Town Council advised that final costs were still being calculated and would be reported in due course.
