#### (i) Meeting with Blessed Edward Jones High School

The Town Clerk advised that following receipt of an invitation from the Chair of Governors at Blessed Edward Jones High School for Councillors at attend a meeting there on 9<sup>th</sup> February 2016, four Councillors had confirmed their intention to attend.

Confusion had then arisen amongst Town and Denbighshire County Councillors and Officers about the nature and purpose of the meeting.

<u>FURTHER RESOLVED</u> that Standing Orders be suspended to enable the Town Clerk to respond as a matter of urgency.

#### (ii) Rhyl Cemetery

Councillor Mrs P. M. Jones raised the matter of the state of the cemetery during the recent heavy rains that had caused significant flooding, preventing mourners from getting to their loved ones' graves. This was naturally causing some distress.

Councillor Jones sought Members' support in writing to Denbighshire County Council to ask about the drainage problem and whether anything more could be done.

General discussion took place about the natural lay of the land and with reference to the need for a new cemetery in Rhyl, Members reminded the meeting of the extensive investigative work carried out by Denbighshire County Council some years ago, concluding that there was no suitable piece land available.
