# 78. FINANCIAL ACCOUNTS TO 30<sup>TH</sup> SEPTEMBER 2017 AND FORECASTS FOR THE 2017/18 FINANCIAL YEAR

Further to minute no.47 of the meeting held on 6<sup>th</sup> September 2017, the Town Clerk presented his and the Finance Officer's joint report (circulated with agenda).

The report showed performance against budget and reported a total forecasted deficit against budgeted expenditure of £98,000 but that this deficit included the proposed contribution of an estimated £150,000 towards the new waterpark.

The report clarified that this contribution would be met by way of savings against budget provision, increased income and the use of the Council's General Reserves.

Referring to appendices a member queried the amount paid for the installation of benches at the Remembrance Gardens which they understood had been provided for elsewhere.

#### **RESOLVED** that:

- (i) the report be received.
- (ii) the Town Clerk to investigate the cost of the installation of the benches and report to the Chair of the Grounds Maintenance Sub-Committee.
- (iii) the Town Clerk to include an item on the next agenda to discuss the production of an early newsletter.

# 79. CONSULTATION: BOUNDARY COMMISSION FOR WALES - "THE 2018 REVIEW OF PARLIAMENTARY CONSTITUENCIES IN WALES REVISED PROPOSALS"

The Chair referred to the above document and the extracts circulated at the meeting and sought members' views.

A debate was held around the proposals and it was <u>RESOLVED</u> that the Town Clerk to write to the Boundary Commission requesting consideration to amend the name of the proposed constituency from "Flint and Rhuddlan" to "Rhyl and Flint" to reflect that Rhyl was the largest and most prominent settlement within the proposed constituency (with some individual electoral wards being larger than other communities) and that the proposed change would make the location of the constituency more easily identifiable given the higher profile of Rhyl due to its resort status.

#### 80. REMUNERATION PANEL FOR WALES - DRAFT PROPOSALS 2018

[Prior to commencement of discussion on this item all Members present declared their personal interest in the matter but advised that the interest was not prejudicial in accordance with paragraph 12(2)(b)(iv) of the adopted Rhyl Town Council Code of Conduct]

The Town Clerk submitted his report (previously circulated) relating to proposals by the Remuneration Panel For Wales in respect of determinations to be made for the 2018/19 financial year, and the potential impact of the proposals on the finances of the Council particularly in respect of budgeting issues.

Members expressed dissatisfaction that the panel was proposing to remove the discretion of Community Councils to determine which allowances would be made available to their individual members, and the potential damage which the proposed determinations would have on the public perception of local councillors regardless of whether individual members chose to accept the allowances.

A Member queried whether the Senior Members Allowance which the Council would be required to pay could be made payable to the Mayor as Chair of Council to offset reductions in the mayoral allowance.

**<u>RESOLVED</u>** that the Town Clerk to prepare a draft response to the consultation document for approval be Council.

# 81. REPRESENTATIVES ON OUTSIDE BODIES

Further to minute no.10 of the meeting held on  $14^{\rm th}$  June 2017, the Town Clerk advised that in respect of

- (i) Rhyl City Strategy the organisation had changed its governance and no longer required a formal representative from the Town Council although an open invitation existed for members to attend its Annual General Meeting.
- (ii) Waterpark Project Board due to an omission in his report to the June meeting a replacement representative had not been made to this DCC board following a former appointed representative not securing re-election to the Council

Members felt that prior to appointment clarification should be sought as to the current status of the board and its remit.

**RESOLVED** that in respect of (i) above the position be noted and that in respect of (ii) above the appointment be deferred to enable the Town Clerk to make enquiries of the County Council.

Members agreed that the event was declining year on year and needed to be reviewed and it was <u>**RESOLVED**</u> that consideration be referred to the Civic and Social Events Sub-Committee for recommendation.
