94. ANNUAL BUDGET / PRECEPT

On the SOP Committee's behalf, the Town Clerk put its recommendations to the meeting, taking into account the likely 2016/17 expenditure outturn, the envisaged 2017/18 expenditure and their recommendations for expenditure in 2017/18 and three options for the 2017/18 precept to be levied.

The Clerk advised that the Chair of the Finance and General Purposes Committee, Councillor P. Prendergast, and Councillor D. Simmons (on behalf of the SOP Committee) had initially gone through the entire budget with him and made their recommendations.

Those recommendations had then gone before the SOP Committee, whose recommendations were contained within the report (circulated with agenda).

The Clerk went through each of the 'headlines' and the following was **RESOLVED**:

- i) to increase the Town Council's contribution towards the Rhyl Air Show from £7,500 to £10,000
- ii) to provide £5,000 towards the infrastructure costs of the Coast to Coast event
- iii) to reduce the Commissioned Services Budget by £5,000 in consideration of (ii) above
- iv) to approve the establishment of a new 'Major Projects' reserve and to transfer the unspent 'Illuminations on the Promenade' and 'Refurbishment of Water Features' budgets to it.
- v) that the Finance and General Purposes Committee recommends Option 2 to Council in that it approves and levies a precept of £497,629 (Four Hundred and Ninety Seven Thousand, Six Hundred and Twenty Nine Pounds) upon Denbighshire County Council for the financial year commencing on 1st April 2017.

vi)	To review the Town Council's Treasury Management / Investment Strategy
	at the meeting of Council to be held on 18th January after receiving
1	recommendations from the SOP Committee.
