1. OPENING OF MEETING & APOLOGIES

The Mayor's Chaplain, Rev. Andy Grimwood commenced proceedings by leading all present in prayer.

2. <u>ELECTION OF MAYOR AND INSTALLATION</u>

Councillor Roberts said a few words about her year in office referring to presenting Rhyl residents who had celebrated their own 90th birthdays in the same year as Her Majesty the Queen, with commemorative coins and Town Council medals as a particular highlight.
