38. <u>PRE-APPLICATION CONSULTATION – RHYL SOUTH EAST FURTHER</u> <u>PHASES</u>

The Town Clerk submitted a pre-application consultation in respect of the above development and asked Members to determine whether they would wish to comment on the proposals.

Members expressed concerns relating to the impact of the development on the adjoining highway network particularly in respect of the B5119 particularly at the Pen Y Maes junction and the "Dyserth Bends" section.

It was felt that clarification was required in respect of planning obligations required from the overall development particularly in respect of the new school and community centre, and the allocation of children play areas and open space serving the estate.

It was also noted that currently a number of persons on the estate would require access to local bus service routes and that it would be beneficial if this could be considered as part of the layout particularly in terms of the provision of bus stops and shelters if appropriate.
