74. <u>APPOINTMENT OF REPRESENTATIVE ON OUTSIDE ORGANISATION -</u> RHYL BUSINESS GROUP

The Town Clerk asked members to consider appointing a replacement representative to the group in view of Councillor T. Thomas having to step down from the position as he had now become Chair of the group. Town Council representatives were not permitted to take up official positions within the organisations.

Follow-on discussions about the Rhyl Business Improvement District (BID) were had, with some concerns / issues raised by members on behalf of town centre businesses.

A suggestion was made for the town council to host a meeting for all Rhyl businesses, at which the BID will be discussed and businesses asked to consider joining the business group or the merits of forming a new group.

RESOLVED that:

- i) the invitation to re-appoint was declined.
- ii) the Town Clerk to report back on the progress of the BID and the issues raised by local businesses, for further consideration.

[Councillor T. Thomas declared a prejudicial interest in the above item due to his position as Chair of the Rhyl Business Group, and vacated the chamber, taking no further part in discussions or voting thereon]

75. PRESENTATION: 'TOGETHER IN DEMENTIA EVERYDAY' (TIDE)

As Ms Helen Wilkinson and Ms Vanessa Van Lierde had arrived the Deputy Mayor invited them to address members.

Ms Wilkinson firstly apologised for their late arrival and went on to advise that:

- the project was DVSC lead and received its core funding from Welsh Government until the end of the project life in March 2021, at which point the aim was that the scheme would be self-sufficient.
- They would deliver a 'dementia action plan' from awareness to action.
- They were looking to establish a Rhyl Action Group.
- They would be happy to return to the town council to deliver a Dementia Friends session, making councillors all official Dementia Friends.

In response to members' questions and comments, Ms Van Lierde advised that:

- They had supported 'Outside Lives', a social enterprise start-up, dementia friendly films at Rhyl's Little Theatre, TIDE Life Story Network and tours of St. Asaph Cathedral.
- They didn't provide a service to people with dementia as such, their work was focussed on raising awareness within communities, but they did signpost to local services.

The Deputy Mayor thanked Ms Wilkinson and Ms Van Lierde for their presentation

76. MEMBERS ITEM: SUPPORTING FAMILIES WITH AUTISM

Councillor B. Blakeley sought members' support for the town council becoming more aware of autism and the many daily challenges it presents for sufferers.

Councillor Blakeley suggested that the town council's small events programme could consider autism friendly elements? Other suggestions were to promote the wearing of 'hidden disability' lanyards to encourage a more understanding reaction from members of the public?

A councillor advised that there were a number of autism friendly initiatives in operation in Rhyl, and referred to a 'no tannoy' hour from 4-5pm in Home Bargains, as a great policy that perhaps wasn't promoted enough?

RESOLVED that a small panel of councillors (Councillors Blakeley, Mrs J. Chamberlain-Jones, Mrs P. M. Jones, Ms J. L. McAlpine and Miss S. L. Roberts) to meet with representatives of Prestatyn Town Council, who already support families with autism, with a view to producing a proposal for the town council to consider introducing
